## 12. First Information contents:

Today i.e. 20th Nov., 2024 at @ 4.30 PM, found a viral video of the interview of one MLA of Manipur namely Paolienlal Haokip with Karan Thapar in YouTube channel of "The Wire" with the description, Biren Singh "mad man & Liar"; HM Protecting Him for Dishonourable Reasons; PM Has "Failed His Job" which was uploaded on 19th Nov., 2024 with more than 1,23,262 views. In the interview MLA, Paolienlal Haokip stated that "yes, obviously, what's there to hide" when Karan Thapar asked him that the brutal killing of 6 civilians (women and children) of Meitei community were done by the Kukis in retaliation. He also stated that in this conflict, some deaths are inevitable. His statements directly incite the different communities living in the State specially Meiteis and Kuki Zo groups to escalate the conflict and create or promote feelings of enmity, hatred or ill will between Meitei/Meetei and Kuki community. Moreover, the MLA, Paolienlal Haokip also advocates and incites retaliatory killing among communities, and he also justifies the brutal killing of different communities in a conflict.

Hence, a suo-mottu case under FIR No. 568(11)2024 IPS U/s 196(1)(a) (b)/353(1)(c)(2)/61(2) BNS has been registered against Manipur MLA, Paolienlal Haokip and other perpetrators for investigation.
