With reference to the above cited subject, I have the honor to submit herewith the enquiry report in c/w the GD Entry No. 09/IPS/2024 dtd. 17/11/2024.

That, on 17/11/2024 at around 11.20 AM, a group of small children along with their parents staged a sit in protest at Keishampat Leimajam Leikai Community Hall, Imphal by violating the prohibitory order of the DM-IW dtd. 16/11/2024 U/s 163 of BNSS as a protest against the abduction and brutal killing of six civilians (women and children) of Meitei community by Kuki militants at Jiribam District and demanding the protection of children. Hence the enquiry.

As endorsed, I have conducted a thorough enquiry in this regard and it was found that on 17/11/2024 at around 11.20 AM, a group of small children numbering about 40/50 along with their parents staged a sit-in-protest at Keishampat Leimajam Leikai Community Hall, Imphal by violating the prohibitory order of the DM-IW dtd. 16/11/2024 U/s 163 of BNSS as a protest against the abduction and brutal killing of six civilians (women and children) of Meitei community by Kuki militants at Jiribam District and demanding the protection of children.

It, is therefore, submitted this enquiry report to take up necessary legal action against the organiser of the sit-in-protest and parents of the innocent children for using small children in a public protest I by violating the prohibitory order of the DM-IW dtd. 16/11/2024 U/s 163 of BNSS.
