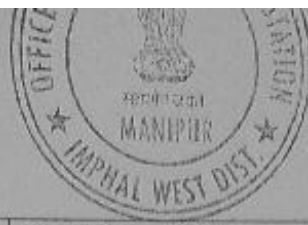

Sir,

With reference to above cited subject, I have the honor to submit herewith inquiry report of above mentioned GD entry with reference to the lost of HSLC examination documents and higher secondary examination document due to flash flood occurred in Imphal area from 29<sup>th</sup> May, 2024 of one individual namely Moirangthem Dhanabir Singh (43), S/o (L) M. Tomba Singh, a resident of DM University Southern Side Kabo Leikai Nongchup. An enquiry has been conducted in this regard. It refers to G.D Entry No. 10/IPS/2024 dtd. 01/11/2024.

During enquiry it was found that, on 01/11/2024 one Moirangthem Dhanabir Singh (43), S/o (L) M. Tomba Singh, a resident of DM University Southern Side Kabo Leikai Nongchup reported to OC Imphal PS stating that his High School Leaving Certificate Examination conducted by Board of Secondary Education Manipur from Bengali High School, Manipur in year 1996 under roll No. 16824 and Higher Secondary Examination conducted by Council of Higher Secondary Education in year 1998 under Roll No. 16546 was lost due to the flash food occurred recently in Imphal. The said individual also submitted a photo copy of affidavit and a news paper cutting publishing his declaration with a request to issue a police report with regards to the lost of his documents. In his affidavit, the individual clearly mentioned that he passed High School Leaving Certificate Examination conducted by Board of Secondary Education Manipur from Bengali High School, Manipur in year 1996 under roll No. 16824 and Higher Secondary Examination conducted by Council of Higher Secondary Education in year 1998 under Roll No. 16546 from Presidency College, Manipur.

Accordingly, requisition was submitted to the Secretary, Board of secondary Education Manipur vide Memo No. 4308/IPS/24 dtd. 15/11/2024 and to the Secretary, Council of higher Secondary Education Manipur vide Memo No.4308/IPS/24 dtd. 15/11/2024 respectively to ascertain the authenticity of the given roll number in the affidavit. A reply letter from Controller of Examinations vide No. Ex/118/78(Vol-XII-pt.IX)/52/288 dated 22/11/2024 was received with the details of the candidate bearing roll No. 16824 of HSLC Examination 1996 as follows:-

As such, the given roll number in the affidavit found to be someone else contrary to the affidavit and it was found that the said individual deliberately furnished fabricated affidavit along with a news paper cutting publishing his declaration to the OC Imphal PS in order to obtain a police report regarding the lost of his HSLC examination documents and higher secondary examination document.

It is therefore, submitted this enquiry report to take up a regular FIR against Moirangthem Dhanabir Singh (43), S/o (L) M. Tomba Singh, a resident of DM University Southern Side Kabo Leikai Nongchup for deliberately making false document with intent to use for purpose of cheating with fraudulent practices.
