11. First Information contents:

Today i.e. 16/11/2024 at 11:45 am received an information that on the same day at @ 11:40 am some unknown Kuki Militants fired out some rounds indiscriminately along with some shells of Lathode/Pompi from the hillside of Aigejang Kuki village, Kangpokpi District towards farmers of Irengbam Awang Maning and adjoining Leimaram Uyok who were peacefully ~~harvesting their paddy fields and thereby attempted to cause serious injuries to life and properties~~.

In that, strong joint teams of District Police assisted by AR, B-08 CRPF, MR/IRB who were deployed tactically retaliated against the Kuki Militants to save the lives and properties of the farmers. In the incident some shells of Lathode/Pompi fell at the paddy field belongs to one Laishram Borojao Singh, aged about 40 years S/O L. Ningthemjao Singh of Irengbam Awang Leikai. However, no one was injured during the incident.

Hence, a regular case under FIR No. 57(11)2024 NBL-PS U/s. 109(2)/310(6)/3(5) BNS, 25(1-A) A. Act & 3 Expl. Subs. Act is registered on Suo moto for investigation.
