12. First Information contents:



It is learnt that, on 13th Nov., 2024 a press meet was conducted by Senior citizen cum advocate Khaidem Mani at his residence located at Loklaobung Moirangkhom in c/w the ongoing crisis and unrest in Manipur. In the press meet Khaidem Mani expressed deep concern over the worsening situation in Manipur, describing it as "from bad to worse" and "uncontrollable." Speaking to the media he urges the State Government either to act or give up power. Further he said that the government is failing to govern the state and the state is in the throes of losing its territorial integrity, and he calls for a large public movement like the Great 18th June Uprising, to overthrow or remove the present government from Power. The video clip of the press meet was gone viral in social media and also published in all the leading local newspaper. His provoking statements intentionally and deliberately incites the common people to raise a uprising to dethrone the present government. Because of his provoking statements, on 16th Nov, 2024 in the evening the common public became very aggressive and distrust against the government. Further, the common people started mobilizing and organising violent attacks against the elected members of Manipur Legislative Assembly one after another causing a huge wrongful loss to the elected members. The violent mob attacked and intimidate the elected members along with their family members and vandalized the government properties and household properties of the elected members causing significant damage to the household properties and government properties. As such, the provoking and intimidating viral post of Senior citizen cum advocate Khaidem Mani not only threat or intimidate or warned the government of Manipur but, also create fear and alarm to the general public and induce any person to commit any offence against the public tranquillity and incites any class of community promoting enmity, hatred or ill-will between classes on the ground of religion caste or community.

Hence, a suo-mottu case under FIR No. 575(11)2024 IPS U/s 196(1)(a) (b)/353(1)(c)(2)/61(2) BNS has been registered against Advocate Khaidem Mani and other perpetrators for investigation.
