Sir,

With due respect, I have the honor to report that today i.e 30/11/2024 at about 07.20 PM, while I along with police team of Imphal PS was conducting intensive frisking and checking under the supervision of OC Imphal in front of Big Toys, Moirangkhom Makha Loklaobung, Imphal one Tata Ace orange in color bearing registration No. NIL, was coming towards our frisking and checking zone from Babupara side was immediately stopped for checking and verification. On spot checking the vehicle, one person namely Md. Rafijuddin (35 yrs) S/O Md. Feijuddin of Lilong Chaobok Mairenkun, P.O & P.S Lilong, Thoubal District was found driving the vehicle with some wood logs concealed by some dry straw. On verification he could not produce any valid documents of the vehicle. Due to his suspicious nature he was brought at Imphal PS along with the vehicle for further checking and verification. On further checking of the vehicle at Imphal PS found 19 numbers of wood log and one poultry feed bag white in color marked as SUPERSTAR was found inside the vehicle. Very surprisingly, on opening the poultry feed bag white in colour found 3 numbers of small wood log along with one pistol with the marking 3372 having 5 numbers of live ammunition was found inside the bag. On further examination he disclosed that the wood logs are illegal red woods and he is a member of an interstate organized syndicate gang and he is a dealer of illegal sandal woods and red woods. So, the wood logs suspected to be illegal red woods and the arm and ammunitions, one money bag containing one driving license of Md. Rafijuddin, one OPPO Mobile Phone Model CPH2269 along with 2 (Two) Airtel Sim cards having Mobile nos. 8730823726 and 6909584798 (as disclosed by him), Tata Ace orange in color bearing registration No. NIL and some loose dry straw were seized at 07.50 PM on production by Md. Rafijuddin (35 yrs) S/O Md. Feijuddin of Lilong Chaobok Mairenkun, P.O & P.S Lilong, Thoubal District by observing formalities. Hence, he was arrested at 08.10 PM by observing formalities.

It, is therefore, handed over the arrested person along with the seized items to you for taking up further necessary legal proceedings and to cause arrest of his associates and the members of the syndicate gang.


