This humble complaint is made to your good office to safeguard our lives and properties from the constant threats of **unlawful organization of "KCP Taibanganba"**.

1. That one Konjengbam Chandani Devi aged 64 years wife of Konjengbam Ibothem Singh of Sagolband Meino Leirak Imphal West District Manipur is a Decree Holder of the Execution Case No. 18 of 2022, the said execution case order was passed by the Honb'le Court for Eviction on 27.09.2024 and the eviction was executed on 16.11.2024, by the official staff bailiff of the Court along with Imphal police personal and they were handed over me the key lock of main gate of suit land. As such date on 26.11.2024 at around 2.00 pm one **Army chief case assistant of KCP Taibanganba** was calling my husband through mobile phone he said that her husband should be coming to the DC Office Lamphelpat at 3.00 Pm even if they will pick up my husband and our life will be danger

That in view of the above facts it is humbly prayed that protection to our lives and properties be taken up necessary action at the earliest.
