With due regard, I the undersigned have the honour to report the following facts. That, on 02/11/2024 in between 3:00 pm to 4:00 pm my elder brother namely Naosekpam Ramsunder Singh aged about 72 years was knocked down by a white colour car bearing registration No. unknown at Lairenpat near Okram Leirak along Imphal Ngariyan Road while he was returned from his paddy field on a bicycle and the white car was fled away the spot. As a result of which he received serious injury on his head and other body parts and evacuated into Raj Medicity for medical treatment. And the bicycle was also partly damaged. I can't report the same in time as the injury of my elder brother is very serious and we are very busy for his medical treatment. Due to his critical nature he was referred to Shija Hospital and Research Institute, Langol and now he is in ICU of Shija Hospital and Research Institute, Langol and undergoing medical treatment.

It is therefore requested to take necessary legal action against the culprits.
