



**11. First Information contents:**

Today, i.e. 07/11/2024, at about 10:00 am received an information that on the same day i.e. 07/11/2024 at about 9:55 am one unknown cadre of outlawed banned organization of KCP came in civvies entered the office of Head Master, Irilbung High School and asked for the headmaster. The headmaster-in-Charge namely Nongthombam Nilakumar asked for the reason. The unknown person without any reason had beaten the headmaster with an iron rod on the right shoulder of the headmaster-in-Charge. The school staffs present there had evacuated him to JNIMS hospital for the medical treatment. It was also informed that earlier the unknown person had served demand letter of KCP to the Principal Irilbung High School.
