Today, i.e. 07/11/2024 at about 2:00 pm received an information that one Mr. Thuanilung Kamei, Information & Public Secretary, Rongmei Naga Students' Organization Manipur (RNSOM) made a PRESS RELEASE dated 7th November, 2024 stating that "Rongmei Naga Students' Organization Manipur (RNSOM) Condemns Kidnapping and Brutal Assault of Railway Driver. RNSOM vehemently condemns the abduction and inhumane assault of Mr. Joshua Kamei, S/o Mr. Kanjei Kamei of Kambiron (Puiluan) Village, Noney District, a 23-year-old railway driver, by Arambai Tengol (AT) extremists near Kheikhu Kabui khul Gate, Imphal East.

On 5th of November, 2024, 12:00 pm, Arambai Tengol militants abducted Mr. Kamei, subjecting him to severe torture and interrogation at their camp. This heinous act constitutes a grave human rights violation, threatening the dignity and safety of Naga people.

RNSOM Demands:

1. Immediate cessation of violent activities by AT extremist
2. Swift investigation, prosecution, and justice for Mr. Kamei
3. Community unity against senseless violence and extortion

RNSOM Warns:


1. Authorities must address the surge in violence to prevent severe consequences

RNSOM's Stand:

1. Zero tolerance for violence
2. No compromise on justice
