Sir,

I the undersigned have the honour to report that on 24/11/2024 at around 1:40 pm, my wife namely Laishram (O) Bina Devi, aged about 39 years along with my younger sister-in-law namely Lourembam Anju Devi, aged about 38 years W/O Lourembam Prasanta Singh of Meitram Awang Leikai went to the house of her sister located at Nambol Chingmang to give some vegetable items on one Honda Activa bearing regd. No. MN06SE-0038. On reaching Utlou near Angoubi Oil Station along Tiddim road at around 2:00 pm, her scooter was dashed to the backside by one Diesel Autorickshaw bearing regd. No. MN01F-7618 which was proceeding from the same direction. Due to impact of which my wife received serious injury on her head and other body parts and now undergoing medical treatment in critical condition at the ICU ward of Little Clinic, Imphal and my younger sister-in-law also got minor injury on her person. I couldnot report well in time while attending medical treatment of my injured sister-in-law at hospital.

It is, therefore, requested to kindly take up necessary legal action against the driver of Diesel Autorickshaw at the earliest.
