Today i.e. 04/12/2024 at 09:35 am received a reliable information that on the same day at about 9:30 am one Ford Figo car bearing Regd. No. MN01AG-0584, red in colour, driven by one unknown driver which was proceeding from Nambol side towards Oinam side dashed to the back side of one Triggo supper scooter bearing Regd. No. Nil, black in colour, ridden by one unknown rider which was also proceeding from same direction at Nambol Sabal Leikai near the entrance of Special Regular English School along Tiddim road due to rash and negligent driving on the part of the unknown driver of the involved Ford Figo car. As a result of which the unknown female rider and two pillion riders including one minor of Triggo supper scooter received sustained injuries on their persons and evacuated to hospital for medical treatment. Both the vehicles were also partly damaged.

Hence, a suo moto case under FIR No. 64(12)2024 NBL-PS u/s 281/125(b)/324(4) BNS has been registered for investigation.
