## 12. First Information Contents.

On 26/08/2024 complainant namely S. Lolindro Singh of CDO-IE Unit lodged a written report to OC/HNG-PS stating that today i.e. the 26<sup>th</sup> August, 2024 at about 8:30 a.m. received a reliable information from 4 AR corroborated with our own intelligence about the presence of some active members of the outfit UNLF loitering at Heingang, Imphal-East District. Immediately, information was given to senior police officers of Imphal-East and teams of CDO Imphal East Unit led by complainant assisted by ASI, Kh. Inaoba of CDO/IE Unit rushed to the said area and conducted random frisking and checking to the suspected passersby and vehicles, verification of person etc. at Heingang Makha Leikai near a brick-field at about 9:00 a.m.

In that, one scooter coming from southern side to the frisking and checking point was spotted. However, instead of paying heed to the signal and shouting for stoppage, the scooter tried to escape the checking team. Immediately, the CDO team overpowered the man and stopped the scooter. He was asked to climb down from the vehicle with their hands up for verification to which they complied. On checking the detainee body, two nos. of mobile phones and one wallet were found and recovered from his possession. On verification, the detainee identified himself as one **Konsam Romesh Meitei (43 years) S/o K. Dhanabir Meitei of Kongba Kshetri Leikai, Imphal East District** an active member of the outfit UNLF (Koireng group). He stated that he joined the said organisation through one s/s – Mr. Jack @ Boicha of UNLF (Koireng group) in the month October, 2023 and presently working under his command. He further stated that on the advice of the said Mr. Jack @ Boicha of UNLF (Koireng group) he had extorted money from various brick-field located at Yumnam Khunou, Waiton and Heingang areas of Imphal East District. He further stated that today, on the advice of the said Mr. Jack @ Boicha of UNLF (Koireng group) he came to collect extortion money from one person at Heingang.

In the above facts and circumstances, the detainee was arrested from the spot i.e. Heingang Makha Leikal, near brick-field at 9:21 a.m. by observing due formalities.

From the possession of arrestee, **Konsam Romesh Meltel**, (i) One scooter (Honda Activa), black in colour, bearing regd. no. MN-01V/1203 having Engine no. JF50E70605311 and Chassis no. ME4JF501BE7605252, (ii) One mobile phone (Redmi Note 10 Pro Max) IMEI no. : 864017058080572/21 & 864017058080580/21 along with two SIM cards having no. Airtel - +91 8131822670 & BSNL - +91 9366080068 (ii) One mobile phone (Samsung SM-B310E) bearing IMEI no. 357116/09/945612/4 & 357117/09/945612/2 along with one Airtel SIM card having no. +91 6909041502 and (iii) one wallet, black in colour, containing a sum of Rs. 500/- (five hundred rupees) and one AADHAR card were seized from the spot i.e. Heingang Makha Leikal near brick-field at 9:28 a.m. by observing due formalities. Hence the case.
