Sir,

As endorsed for enquiry in c/w above G.D entry No. 15/IBG-PS/2024 Dated 13/12/2024 after obtaining permission from SDPO-PRT, I have honour to submit the finding as follows:-

The brief of the report is that one SI. Kh. Victor Singh, Commando Imphal East Unit have handed over the seized articles with a written report to OC, IBG-PS stating that on 13th December, 2024 at about 4:00 a.m. received a reliable information from 5/9 Gorkha Rifles corroborated with their own intelligence about the presence of some anti-social elements in and around Keirao Khunou, Imphal-East District. Based on the said information, a combined team of CDO/IE Unit and a column of 5/9 Gorkha Rifles assisted by SI. S. Lolindro Singh of CDO/IE Unit under the command of Inspt. Kh. Henery Singh, OC-CDO/IE Unit and under the supervision of Shri. Kh. Herojit Singh, MPS Addl. SP(Ops) Imphal East District conducted a searched operation in the general area of Keirao Khunou, near MAASI, Imphal-East District and its adjoining foothills at about 4:00 a.m.

During the search operation, a yellow sack bag containing a nos. of arms, ammunitions and explosives were found lying abandoned at the northern side of the foothill of Keirao Khunou, near MAASI, Imphal East District. Thereafter, the recovered under noted arms and ammunitions were seized from the spot i.e. northern side of the foothill of Keirao Khunou, near MAASI, Imphal East District at 5:39 a.m. by observing due formalities.

- (i) 1 (one) MA4 Assault Rifle (Myanmar) bearing regd. no. 'C5010', fitted with one empty magazine & a green sling,
- (ii) 1 (one) 12 bore single barrel Gun bearing regd. no. '17017', fitted with a green sling,
- (iii) 1 (one) 9 mm Pistol bearing regd. no. 'P-1707' fitted with one empty magazine,
- (iv) 1 (One) .32 Pistol bearing regd. no. 'T-0204' fitted with one empty magazine,
- (v) 5 (five) nos. of Hand Grenade,
- (vi) 5 (five) nos. of Arming Ring,
- (vii) 2 (two) nos. of Detonators,
- (viii) 30 (thirty) nos. of 5.56 mm ammunitions,
- (ix) 2 (two) nos. of 12 bore ammunitions,
- (x) 3 (three) nos. of 9 mm ammunitions and
- (xi) 2 (two) nos. of .32 mm ammunitions.

During the course of operation a specific information was further received that some electronic equipment use for connecting internet satellite are kept concealed at the nearby hilltop/ hill ranges. Thus conducted the operation in and around the foothill and hill- top of Keirao Khunou. In that one white sack bag containing one internet satellite kit was found kept concealing inside a bush in the white sack bag, recovered the following items and seized from the spot i.e about 500 meters above the foothill of Keirao Khunou, Imphal East District by observing due formalities at 5:43 am.

1. 1 (one) Starlink Internet Satellite Antenna,
2. 1(one) Starlink internet satellite Router.
3. 20 meters (Approx.) of FTP Cable.


Hence the report.

In the enquiry it is found that in the starlink internet satellites phone it is written by red marker as RPF/PLA and incriminating articles are kept concealed for their prejudicial activities. Therefore the Section 20 UA (P) Act, 25(1-C) A. Act, 3 Expl. Subs. Act including 3(5) BNS, 2023 is attracted.

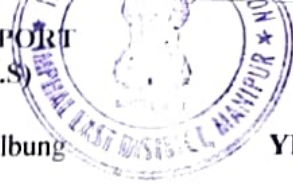
