Sir,

I have the honour to report that, I have investigated an UD case having UD Case No. 06/NBL-PS/2024 Dated 23/11/2024 U/S. 194 BNS regarding the dead of one unknown male which was found lying death on the southern side drain of Leimaram Lamkhai IVR on 23/11/2024 at 9:40 am. The cause of death is uncertain.

During the course of investigation, visited the spot and inspected minutely with the help of a mobile team of District Mobile Forensic Unit, Bishnupur. The spot was photographed from different angles and also drawn a rough sketch map of the P.O. with proper index. Identified the deceased person as one Laimayum Debadutta Sharma aged about 34 years S/o L. Krishna Sharma of Waikhong Ningthoumanai, Kakching District, Manipur. Inquest and Post Mortem examination were conducted over the dead body by observing due formalities and handed over to the family members. On 23/12/2024 collected Post Mortem Examination report of the deceased from the Forensic Medicine, RIMS, Imphal and the concerned doctor opined that "The death was due to intracranial hemorrhage associated with skull fracture resulting from blunt force injury to the head", "Homicidal in nature". From the P.M. examination report, it is highly suspected that the deceased was murdered by unknown culprit(s).

Since the deceased is suspected to be murdered by unknown person(s) which is tantamount to an offence under section 101 BNS, the present U.D case is required to be converted into a regular FIR case for proper investigation.

So, in order to investigate properly, it is requested to kindly take up a regular FIR case against the unknown accused person(s) for further investigation.
