Sir,

Today i.e 01/11/2024 at around 6.30 pm some unknown persons numbering around five (5) barged inside my rented house located at Friends Colony, Mantripukhri and started to search for me, suddenly I heard altercation of my wife with unknown persons, I came out from my room to enquire, to my utter surprise the unknown's person started to ask many irrelevant questions to which I denied. However, the unknown persons demanded a huge amount Rs.5,00,000/- (five lakh), I denied that why should I pay the said amount. In which from among the unknown persons pulled out a gun and pointed on my head threatening me to kill if I didn't cough up the said amount. I requested them, that I don't have the said huge amount. They further started to search my almirah and found nothing. Later on, they threatened and asked me to arranged the said amount from my friends. Due to fear for safety of my wife and self, I called my friend Md.Irshad Alam and requested to arrange an amount available with him in which my friend sent me Rs.87,000/- (eighty thousand) through G-pay to my account. Further, in my account I have Rs.13,000/- (thirteen thousand) totaling an amount of Rs.1,00,000/- . I requested them that I could arrange only one lakh and they directed me to transfer the said amount to an account by scanning QR code provided by the unknown person through G-pay in which the name was shown as of Miss Ruhi(mknawazkhan53@oksbi). The amount Rs.1,00,000/- was sent by breaking into Rs.50,000/-, Rs.20,000/-, Rs.17,000/- and Rs.13,000/- respectively. After the transfer of the amount, they snatched my mobile and remove sim card and they further threatened not to inform anybody regarding the incident.

It is therefore requested to kindly arrest the involved culprits and recover my extorted amount.
