

In continuation with 'War on Drugs' today i.e., 06/01/2025, a combined team of Senapati District Police, Forest team Senapati, SDC/ Executive Magistrate Senapati, Senapati District led by ADDL.SP(L/O)-SPT under the supervision of SP - Senapati and DC - Senapati conducted an intensive Poppy/cannabis plants destruction drive at Sorbung Hills ranges: Lat. 25.272616° and Long. 94.145579°. In that, around 24 Acres of standing poppy plants were destroyed. The approximate value of the destroyed poppy is Rs. 1,68,00,000/- (One crore sixty Eight thousand) only. However, no cultivators were visible during the destruction drive.

Hence, a Suo-Moto case under FIR No. 01(01)2025 SPT-PS U/S 18(b)/46 ND&PS Act 1985 has been registered for investigation.
