Sir,

With due regards, I beg to state that today on 23/01/2025 at about 4:00 a.m received an input from 165 TA and corroborated by 4 AR and 5/9 GR that some unknown armed miscreants have stored and hidden some arms, ammunitions and explosives at the foothill of Fungei Ching, Ngamukhong village for using offensive act against State Security Forces and CAPF.

On receipt of the information, Special Operation Group (SOG) Thoubal District Police along with 4 AR COB, Chandrakhong (including ARL-670 ED Dog Ruby) and 5/9 GR led by Insp. K. Nitaranjan Singh, OC/CDO-TBL under the command of Shri. H. Devendra Singh, Addl. SP(Ops)/TBL and under the overall supervision of Shri Rakesh Balwal, Sr. SP/TBL have rushed to the spot immediately and launched a massive operation at 4:30 am by using metal detectors. On searching and found the undernoted articles i.e. (i) 1(one) no. of Country made SBBL, (ii) 1(one) no. of 9mm Country made Pistol along with mag, (iii) 1 (one) No. of 9mm mag, (iv) 10(ten) no. of 36 HE Hand Grenade, (v) 1(one) no. of Radio Set Baofeng, (vi) 1(one) no. of Anti-Riot Grenade, (vii) 1 (one) no. of Stun Shell (normal), (viii) 50(fifty) nos. of .303 Blank Cartridges, (ix) 9(nine) nos. of .303 live rounds, (x) 10(ten) nos. of 7.62x39 mm live rounds, (xi) 17(seventeen) nos. of 9mm live rounds, (xii) 3(three) no. of 7.62x39 mm empty case, (xiii) 14(fourteen) no. of 7.62x 51 mm empty case, (xiv) 13 (thirteen) nos. of .303 empty case &(xv) 15 (fifteen) nos. of 5.56 x 45 mm empty case, from the spot and seized at 5:45 am. The massive searched Operation was conducted from 04:30 am to 7:00 am on the same day.

So it is therefore, handed over the seized articles to you for your kind consideration and further necessary action.
