As endorsed I have made an enquiry on the report submitted by S Thangmuanlal (42) s/o S Thiankhomang of Hill Town, CCPur, PRO to MLA, 58 A/C Churachandpur regarding a sensitive whatsapp comments posted by one Sang Vp using mobile number +918798330549 in Zalengam Media (whatsapp group) on the evening of 12th January, 2025 against two prominent elected leaders ie Hon'ble MLA Shri Vungzagin Valte and Hon'ble MLA Shri LM Khaute. The whatsapp comments posted by the said person (screenshot copy enclosed) is highly derogatory, abusive and defamatory. Such baseless comments, derogatory abuses, unfair criticism and humiliation of our elected public leaders in a public platform like whatsapp group at this critical juncture have the potential to flare up communal tension and lead to inter community violence. Further, the same individual also urges and instigates the Kuki UGs and Kuki Village Volunteers (KVV) to kill the above mentioned public leaders. The said individual who posted the highly illegal and objectionable comments and the persons who manage the Zalengam Media as admins are liable for strong legal action under the law as they have clear intentions to cause physical harm to the two elected leaders, damage their reputation and create chaos/ inter community violence.

Enquiry reveals that the person using mobile number +918798330549 (Airtel Sim) is Mr Thanglensang (42) s/o Late Chungjathang of Lingsiphai Village, Churachandpur and the report is found to be genuine and he had indeed posted/ shared the derogatory messaged in the whatsapp group Zalengam Media and further he was found to be one of the admin of the said group. In this regard, a regular case needs to be registered for smooth investigation.

The whatsapp comments posted by the said person (screenshot copy enclosed) is highly derogatory, abusive and defamatory. Such baseless comments, derogatory abuses, unfair criticism and humiliation of our elected public leaders in a public platform like whatsapp group at this critical juncture have the potential to flare up communal tension and lead to inter community violence. Further, the same individual also urges and instigates the Kuki UGs and Kuki Village Volunteers (KVV) to kill the above mentioned public leaders.
