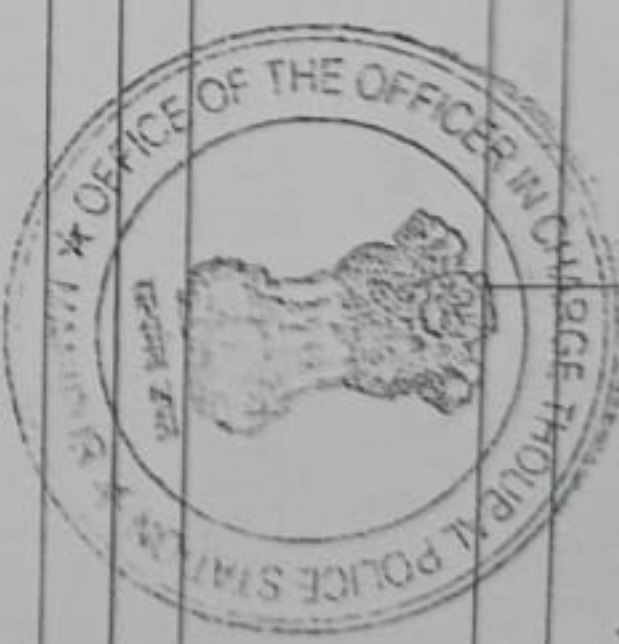

Today i.e. 9/1/2025 at about 8:10 pm, received an information that on the same day at about 8:00 pm, one Tata Magic bearing regn. no. MN04A5766 proceeding from Wangjing towards Heirok side along Wangjing Heirok Road collided with one Honda CBZ bearing regn.no. MN04B6082 which was coming in the opposite direction at Wangjing Awang Leikai Hodamba due to rash or negligent driving/riding on the part of unknown driver/rider of both the vehicles. In that, unknown rider of the said Honda CBZ and its two unknown pillion riders were injured. The injured persons were evacuated to District Hospital, Thoubal. Both vehicles were also partly damaged.
