I, the undersigned would like to report that, vide SP/CCP Order No. mentioned above, combine team comprising of District Police Churachandpur, Indian Army, CRPF, NAB/Churachandpur, CCP/Forest Division and CCP-PS team launched destruction of illegal poppy cultivation in Siden-Changpikot Village, Churachandpur between 11:00 am to 3:30 pm in the presence of Executive Magistrate. Total area of illegal poppy cultivation destroyed was estimated to be 12 acres approximately. During the operation, no arrest was made and the cultivators are not known. However, 05 pieces of poppy plants without pods have been seized in the presence of witnesses at about 2:00 pm.

The illegal poppy cultivation destroyed is estimated to be worth Rs 75,60,000/- ( Seventy Five Lakhs Sixty Thousand Thousand) approximately, in international market.
