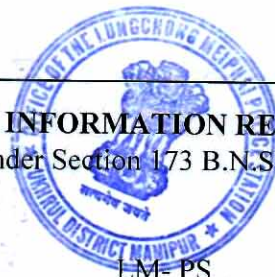

**First Information contents:** In response to SP/Ukhrul vide order no. C-1(G/P)/2024-SP(UKL)/136 dated 06/01/2025 a combined team of Ukhrul District Police, 6<sup>th</sup> Bn. Manipur Rifles, 18<sup>th</sup> Assam Rifles and District Forest Department led by Shri. Hopeson Chiphang, MPS, SDPO/UKL, Shri. Chonreingam Raising, MPS, SDPO/JSM & Shri. Chongtham Sarjan Singh, MPS, SDPO/CGI under the supervision of Superintendent of Police, Ukhrul conducted illegal poppy destruction at Phalee & Champhung hill range, Ukhrul District, Manipur on 08/01/2025 to 10/01/2025 at 10:30 a.m. to 4:00 p.m. by the order of the Magistrate on duty who furnished Attachment and Destruction order of illicit poppy cultivation in the said area U/S 18(b) ND & PS Act, 1985 (as amended). An area of about 135 (one hundred thirty five) acres approximately was destroyed. It is expected to yield about 1350 (one thousand three hundred fifty) Kg, 10 Kg per acre of opium (Approx). None came forward to claim the ownership of the cultivated land. Thus, seized some poppy pods for inducing into evidence (if required) in the Court and for further legal action.

Hence, a Suo- Moto case under **FIR No. 01(01)2025/LM-PS, U/s 18 (b) ND & PS Act** was registered and endorsed to ASI. CL. Mathew for investigation.
