I have the honour to state that, today i.e. **05/02/2025 at around 07:00 pm**, received an information about the presence of anti-social elements at Makeng Cheijingba Village, Near Poumai-Maram land disputed area under Senapati Police Station. Acting on the information, teams of Senapati District Police comprising of **Shri. Thangkhochon Haokip, MPS, Addl. SP (L/O), Senapati, Shri. H. Timothy Maram, MPS, Addl. SP (Ops), Senapati, Self (Loshuo Koso) of Senapati PS and 1 (one) Women Police officer and 1 (one) women personnel from Senapati WPS** conducted search operation at around **07:30 pm**.

On suspicion, one house having Red Tin Roof owned by B.K. Vikhutu (29) yrs s/o Kavisii was searched in presence of 6(six) persons who were inside the house by observing necessary formalities. One sack (blue in colour) filled with suspicious items was recovered from the store room. On Suspicious of being illegal items, the sack was taken out from the store room and taken to the PS along with suspected 2(two) persons who were there.

Immediately, DC/Senapati Office was contacted for sending one Executive Magistrate. Accordingly, Shri Rang David Kung, MCS, ADC/ADM arrived at the PS and in his presence, the owner of the house namely B.K. Vikhutu (29) yrs s/o Kavisii opened the sack and took out one broken soap case containing suspected Brown Sugar wrapped with a torn plastic, rubber band weighing about 4.700 kgs suspected to be used for binding soap cases of brown sugar and 68 (sixty-eight) Nos of plastic wrapper (19/12 cm in size) suspected to be used for packing brown sugar. So, the two persons were arrested by observing formalities.

On weighing the Brown Sugar, it weighed 13 grams including the weight of the torn plastic (excluding the broken Soap case). On searching their bodies, one Mobile Phone each were recovered from their possession and seized in presence of the witnesses by preparing a seizure memo.
