With due respect, I Smt Ningthoujam Sonia Chanu aged about 38 years w/o Loitongbam Jimmy Carter, resident of Thengra Leirak, Churachandpur would like to lay the following few lies for your kind consideration and necessary action.

That, I got married in January, 2012 and has been residing at Thengra Leirak, Churachandpur. And that due to my husband's posting at Imphal we started residing at Meitram Makha, Imphal West since 2020 and has two residences till then. That on 03rd of May, 2023 at about 5:00 Pm, I was informed that some unknown armed persons numbering about thousands belonging to the Kuki community started attacking our house and family members. Thereafter, they started destroying, looting and burning my house (first floor) resulting in razing of the whole property into ashes which continues for the next three consecutive days. I was reported over mobile phone that they even threatened to kill my whole family pointing guns and other weapons against them. At that time, I along with my husband were at Meitram Makha Leikai. My relatives witnessed the destruction/ burning/ looting of our house and properties which is totally inhuman and deadly.

I was in a total mental trauma from the incident that shocked our mind till date and we incurred a huge lost in the incident that is still haunting the state. All household properties and the first floor where we resided was totally looted, damaged and burned. The details of the properties lost are follows: Brick house @ Rs 20 lakhs, Furniture items @ Rs 07 lakhs, Accessories @ Rs 03 lakhs, Gold 10 mohor @ Rs 20 lakhs and cash Rs 06 lakhs, total: 56 lakhs.

On that, every day, a rally organized by ATSUM was held and participated by thousands of people belonging to the Kuki &

Paite tribe in Churachandpur District and the mob with criminal intention from the rally incited the incident of torching/burning/ -destruction/looting of properties, house and places of worship belonging to the Meitei communities in Churachandpur District and its periphery. The mob were armed with deadly weapons and sophisticated guns. I could not report well in time due to lack of legal knowledge and mental trauma.

In view of above facts and circumstances, I therefore respectfully request you to kindly cause arrest the miscreants who belong to the ATSUM/ Kuki/ Paite communities involved in the burning/ destruction/ looting of my properties and take up an FIR against them as soon as possible for the interest of justice.
