As it lies in a Kuki dominated area. On 03/05/2023 at around 6:00 PM some unknown persons suspected to be Kuki militants started to gut fire after valuable properties were stolen/ looted away by the said unknown persons suspected to be Kuki militants ie 22,000 nos of brick worth @ Rs 3,19,000/-. Thereafter, I along with my family members taking shelter at Mekola Gulap Higher Secondary School Relief Camp till date. I couldnot report well in time due to lack of legal knowledge, mental trauma and displacement.
