I am the Chief of Phuaisanphai Village and a permanent resident of the said village which is located at Kangvai Sub Division, PO/PS and District: Churachandpur, Manipur.

That, due to the ethnic violence that erupted in the state of Manipur between the majority Meetei/ Meitei and the minority Kuki-Zo, we deserted our above mentioned village on the 24th of May, 2023 at around 4:30 PM few hours before they attacked our said village.

That, it came to my knowledge from a reliable source, that on the 02nd of Feb, 2025 at around 3:40 PM a mob of unknown miscreants had looted and vandalised the installed water pipes which was issued to the village under the Scheme 'Jaal Jeevan Mission (JJM)' along with the village electric transformer.

That, the above mentioned village/ public properties which were looted and vandalized by unknown miscreants were carried out parts by parts after the dissertation of the village.

That, the illicit act by the unknown miscreants have incurred huge lose which is estimated to be about Rs 23,00,000/- only inclusive of the said water pipes (JJM), water tanks and the electric transformer.

Therefore, I humbly pray you to kindly register an FIR looking towards your positive necessary action. I shall always remain grateful to you and obliged.

That, the above mentioned village/public properties which were looted & vandalized by unknown miscreants were carried out parts by parts after the desertation of the village.

That, the illicit act by the unknown miscreants have incurred huge lose which is estimated to be about **Rs.23,00,000/- (Rupees Twenty-Three Lakhs)** Only inclusive of the said *water pipes(JJM), Water Tanks* and the *electric Transformer*.

Therefore, I humbly pray you to kindly register an FIR. Looking towards your positive necessary action. I shall always remain grateful to you and obliged.


