Kappu of Gouchinkhup Veng, New Lamka, CCPur, President, YVA(GHQ) # 8974782684 stating that on 05/02/2025 at around 09:15 PM in which Mr. E Lianthianlal (33) s/o Tinzalun of Nghathal Village, CCPur(Executive Member, YVA Lamka Block) riding one TVS Jupiter(Brown Colour) bearing Regd No. A/F moving from New Bazar towards Nghathal was directly hit from the front by One Bolero (White Colour) bearing Regd No. Unknown, driven by unknown coming in the opposite direction and fled away without paying any heed. Mr E. Lianthianlal was immediately rushed to District Hospital, CCPur for medical treatment and admitted due to critical condition. He was grievously injured and his vehicle was also badly damaged due to rash or negligent driving on the part of the unknown Bolero driver. The incident occurred along Tedim road, Near Rayburn High School, New Lamka, CCPur.

As per enquiry the report was found genuine and true. Visited and inspected the PO. Check CCTV footage in and around the vicinity and along Tiddim Road but the unknown driver as well as the Bolero White in colour couldnot be identified till date. The victim was seriously injured and undergoing medical treatment and kept at ICU, District Hospital, CCPur as his condition was critical. Also, his vehicle was badly damaged and was recovered from the spot and kept at CCP-PS for safe custody.
