Subject: Request for FIR registration regarding dismantling and destroying the House and Household Property.

Respected Sir,

I, RK Ramping, Headman/Chairman of Maremei Village, am writing this formal application to request the registration of a First Information Report (FIR) in connection with an incident of unlawful dismantling and destroying of my house and all the household property. The incident occurred on the 11<sup>th</sup> January, 2025, around 1:00 P.M at my residence.

I wish to inform you that on the mentioned date, unauthorized individuals numbering around 200 entered my residence and unlawfully dismantled and destroyed several household items, causing significant damage and loss. The items involved include furniture (chairs, tables, sofas, etc.), electronic appliances (TV, refrigerator, washing machine. etc.), plumbing fixtures, Sintex (water tank), pipes, roofing materials, kitchenware, and other miscellaneous household goods.

The estimated value of the damaged and destroyed items is approximately Rs. 33,31,800 (**Thirty-three lakh thirty-one thousand and eight hundred Rupees**) based on the current market rates, which is attached along with this application. The unlawful act has caused considerable inconvenience and financial loss, and I request that the police take necessary action to investigate the matter and book the following persons who had spearheaded in the incident:

1. Mr. Mariwangbou Newmai (Francis), from Liangmei Taphou Village.
2. Mr. MR Willinbou, from Thonglang Akutpa Village.
3. Mr. MR Johnny, from Liangmei Taphou Village.
4. Mr. Ch. Tithobou, Chairman, Chawang Kining Village, LNC Vice-President.

They are the people who were encroaching and constructing huts and hovels on my land, of which some were dismantled. Following which they had retaliated it. I kindly request you to register an FIR and initiate a thorough investigation into the matter. I am attaching all relevant documents and evidence related to the incident, including photographs of the damaged property, to assist in the investigation. Documents related to land and judgement issued by the competent authorities are also enclosed.

I would be grateful if you could take immediate action on this matter and keep me informed of the progress of the investigation.
