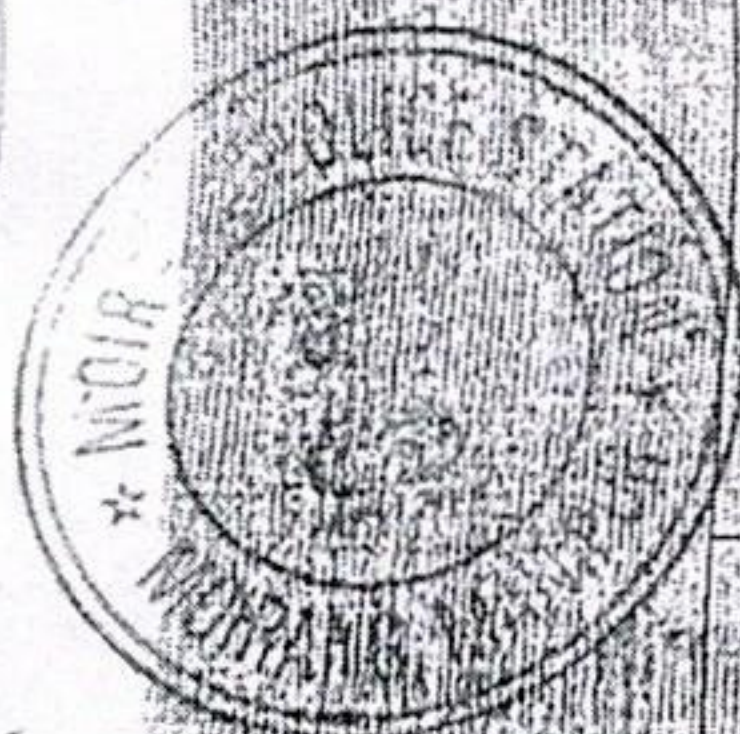

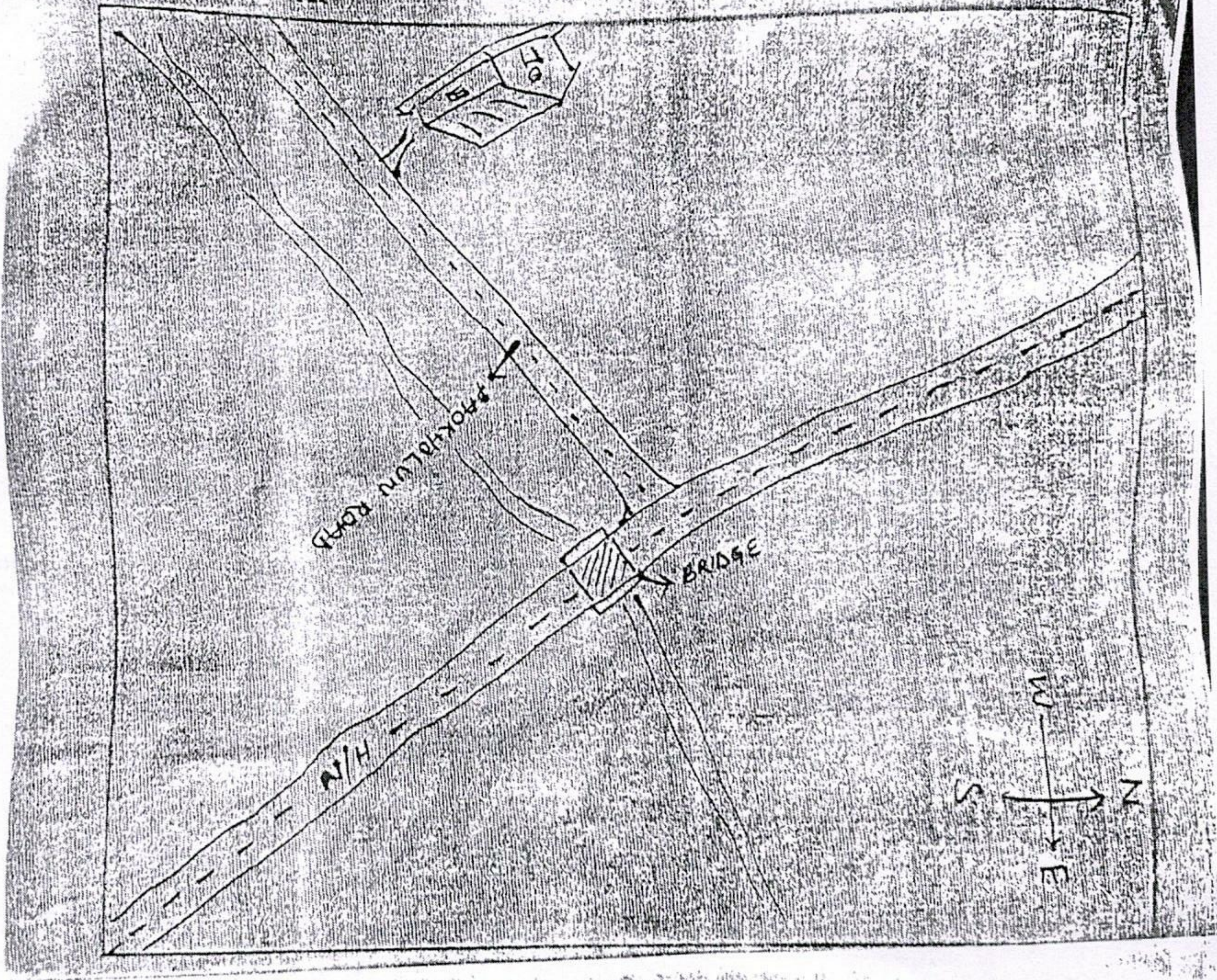

Head & Neck:

Increased FDG uptake is noted in ill-defined heterogeneously enhancing mass in the left parotid gland (size 4.0 x 3.8 x 4.3 cms, SUVmax 7.3). There is involvement of superficial and deep lobes of parotid gland.

No enhancing mass lesion or focal abnormal FDG uptake seen in the nasopharynx / oropharynx / hypopharynx and larynx.

Both lobes of thyroid appear normal in size with no focal hypodense lesion / focal abnormal FDG uptake.

Increased FDG uptake is noted in left level II, V & right level IV cervical lymph nodes (size 1.9 x 1.5 cms, SUVmax 7.9 in left level II station).

Chest:

Increased FDG uptake is noted in lobulated mass in the anterior vessels segment of lower lobe of right lung (size 3.9 x 4.8 cms, SUVmax 7.3). No chest wall infiltration / mediastinal invasion seen.

Increased FDG uptake is noted in multiple soft tissue density nodules in both lungs (size 3.0 x 2.8 cms, SUVmax 11.3 in upper lobe of right lung). Minimal right pleural effusion seen.

Increased FDG uptake is noted in right upper paratracheal, right lower paratracheal, right hilar, subcarinal and prevascular lymph nodes (size 1.9 x 1.3 cms, SUVmax 9.6 in right upper paratracheal station).

Esophagus appears unremarkable with no mural thickening / mass lesion.

Abdomen:

Liver appears normal in size with no evidence of focal FDG uptake/hypodense lesions. No significant IHBRD seen. No evidence of gall bladder calculi.

Spleen appears normal in size with no focal hypodense lesion or focal abnormal FDG uptake.

Stomach, small and large intestine appear normal with no mural thickening/mass lesion/focal abnormal FDG uptake.

No mass lesion/focal abnormal FDG uptake seen in the pancreas. No significant dilatation seen in the main pancreatic duct.

Bilateral adrenal glands appear normal in size with no focal nodularity or focal abnormal FDG uptake.

Both kidneys appear normal in size, position and show no mass lesion. No evidence of hydronephrosis or calculi.

Uterus appears normal. No obvious adnexal pathology seen.

No significant hypermetabolic abdominal and pelvic lymph nodes seen.

Musculo-skeletal:

Increased FDG uptake is noted in expansile destructive mass involving the occipital and left temporal bone with soft tissue component (SUVmax 11.9). There is compression of left cerebellar hemisphere. Opacification seen in left mastoid air cells. There is infiltration of deep muscles of neck.

Increased FDG uptake is noted in lytic lesions in right acetabulum, D9 vertebra and right 4th rib (SUVmax 4.5 in right acetabulum).

No focal abnormal focal FDG uptake seen in rest of the body.

Physiological tracer distribution is seen in the brain, myocardium, kidneys, ureters and urinary bladder.
