Today i.e. 12/01/2025 at 09.10 am received a reliable information that on the same day at around 09.00 am, one Honda Activa, dark blue in colour without registration number playing from Tekcham Bazar side toward Sapam side ridden by one unknown rider, collided with another Royal Enfield Meteor, 650, black in colour, Bearing Registration No. MN04G-6536., plying from opposite direction i.e. from Sapam side towards Tekcham Bazar side driven by an unknown rider, near the gate of Heigrujam Jadu Singh of Sapam Maning Leikai, along the IVR of Sapam- Tekcham, due to rash and negligent driving on the part of the unknown rider of Royal Enfield Meteor, 650, black in colour, Bearing Registration No. MN04G-6536, as he try to overtake a four wheeler vehicle travelling in front of him. As a result of which the unknown rider and the pillion rider of Honda Activa, sustained serious injuries on their persons and evacuated to District Hospital Thoubal for medical treatment. And the Honda Activa is also badly damaged.

Hence a regular suo-motu case under FIR No. 01(01)2025 KJM PS U/S 281/125(b) /324(4) BNS 2023 has been registered for investigation.
