No. Nil red in colour of Taj Ahmed Khan towards Arapti Lamkhai, some armed miscreants numbering around 15 wearing camouflage (Like CDO dress) stopped him by pointing guns like Insas rifle and assaulted him by using sticks without giving any reason. Complainant Mohd. Zabir Khan his elder brother Md. Sabir Khan is a VDF personnel posted at Traffic Police, Lilong. As a result of which his elder brother got injured on leg, neck & back of his body. Immediately he was evacuated to Noor Hospital & Research Institute, Lilong by nearby people of the said area as he was found lying on the road unconscious. Presently my elder brother is now at a state of unmovable condition. Hence the case.
