In pursuance of Sr. Superintendent of Police, Thoubal Dist., Manipur vide Endst. No. 6/2/2024/SP-TBL/9278, dated 31/12/2024, regarding to take necessary action of the complaint letter submitted by Khangembam Raju Singh, S/o Kh. Abiram Singh of Khongjom Chingtham Maning Leikai, which was forwarded with the endorsement.

Accordingly a regular case under FIR No. 02(01)2025 KJM PS U/S 316(2) BNS 2023 has been registered for investigation.

The complaint report is narrated as below :-

Subject : Report under Section 173 BNSS against Shri Lourembam Romeo Singh, aged about 29 years, S/o Late Lourembam Kula Singh of Thoubal Mela Ground, P.O & P.S. -Thoubal, Thoubal District, Manipur.

Sir,

I, the undersigned, am submitting herewith the present report for immediate action:-

1. That I have taken on loan a vehicle - Maruti Celerio xzxi(o) bearing Engine No. K10BN8330279, Chassis No. MA3ETDE1S00679357, Regd. No. MN01AG7949 from the Axis Bank, Kakching Branch. I am still paying the EMI for the said vehicle.
2. That the aforementioned Shri Lourembam Romeo Singh, is my brother-in-law who is the husband of the elder sister of my wife and on his request, I entrusted my said vehicle to him on the condition that he will use the same in good and motorable condition and that he will return the same, as and when demanded.
3. That in the first part of August, 2024 as I received many calls from the Motor Insurance Company for renewal of the insurance policy of my said vehicle, I called my said brother-in-law to bring my vehicle so that I may renew the insurance Policy. But he refused to bring the same.
4. That as my brother-in-law repeatedly failed to return the said vehicle, I have made a discreet search and found that he has kept the same in the custody of one Sanasam Ongbi Bijeta Devi, aged about 40 years, W/o S. Maipaksana @ Inao of Thoubal Sabaltongba, PO. & P.S. Thoubal District, Manipur. Now the said Bijeta Devi has refused to return my vehicle saying that my brother-in-law has mortgaged the same to her.
5. That my brother-in-law has no right and authority to mortgage without my consent.



6. That in the aforesaid manner, my brother-in-law has dishonestly misappropriate my said vehicle which is registered in my name. But my brother-in-law has committed offence punishable under section 316(2), BNS.

I am, therefore, to file the present report to make proper investigation by registering appropriate FIR and to arrest the culprit and recover my vehicle.

I cannot file this report any earlier as I have been trying to have the matter amicably without resorting to police action. But now I have no other alternative but to file the present report.
