Subject : Request for lodging FIR against the people in detaining and assaulting the Forest Staff of Thoubal Forest Range.

Sir,

With reference to above cited subject, I have the honour to state that our Range Forest Office, Thoubal staff on their routine patrolling in Tentha Area met an unfortunate incident on 3rd January, 2025. As per our daily duty, combine team of our forest staff (Yairipok Beat and Thoubal Range Staff) went to Tentha Area as regular patrolling in three vehicles (MN1K 2070, MN01K 5492 and Tata Yodha). At around 05.10 pm, our team detected felled trees, tree stumps of freshly cut trees near the road side and along the slope of the Tentha hill and also found a portion of damage area of the hill due to illegal excavation of hill earth which have been done recently (as per from observation). Our team enquired a passerby and found out the felled trees are to be used for the construction of a house at the excavated area. While having a conversation, the nearby villagers started ringing electric post to gather and create a mob. Immediately, our team came out from Tentha area at Samaram Road and met a crowd. The First vehicle had passed through the Samaram road, the last vehicle escaped through Tentha- Tekcham road but got damage on the vehicle's Windshield glass, rear glass and right-side window glass of the driver and passenger as the crowd started pelting stone towards the vehicle. The middle vehicle was detained by public and ask to wait for the owner (Maibam Priyobarta Singh, S/o- Maibam Joymangol Singh of Tentha Mathak Leikai) of the timbers that we had recently seized from Tentha Area which had been registered as Offence No. 19 of 2024-25 of Thoubal Range. As soon as the crowd started physical assaulting the detained forest staffs causing sustained injury, they spread out and take sheltered at nearby safe place. The team of Khongjom P.S. rushed in and rescued the detained forest staff and recovered the vehicle.

It is hereby submitted for favour of your kind perusal and further necessary action.
