On 18/01/2025 at 7.30 am received a complaint report from one Jem. Md. Amin Khan J.C. No. 843 of 7<sup>th</sup> MR Now attached with CDO/TBL reported that on 18/01/2025 at about 04:30 a.m. he received a reliable information that some unknown armed miscreants have stored and hidden some arms, ammunitions and explosives at the foothill of Ushoipokpi area for using offensive act against State Security Forces and CAPF.

On receipt of the information, Special Operation Group (SOG) Thoubal District Police along with two column of 4 AR led by Inspt. K. Nitarnan Singh, OC/CDO-TBL under the command of Shri. H. Devendra Singh, Addl. SP(Ops)/TBL and under the overall supervision of Shri Rakesh Balwal, Sr. SP/TBL have rushed to the spot immediately and launched a massive search operation at 05:00 a.m. On searching and found the undernoted articles i.e. (1) 1(one) no. of Single Bore Barrel (Sniper), (2) 1(one) no. of Country made Rifle, (3) 1(one) no. Amogh carbine magazine, (4) 3 (three) nos. of .303 magazine, (5) 1 (one) no. of HE Hand Grenade, (6) 1(one) no. of Detonator, (7) 5(five) nos. of 7.62 x 39mm live rounds, (8) 6(six) nos. of .32 live rounds, (9) 1(one) no. of 9mm live round, (10) 6(six) nos.



of .303 empty case, (11) 4(four) nos. of 7.62mm (SLR) empty case, (12) 6(six) nos. of 7.62 x 39mm empty case, (13) 1(one) no. of Green Smoke 80MK1, (14) 2(two) nos. of Stun Shell (N), (15) 3(three) nos. of Tear Smoke Shell(S/N), (16) 3 (three) nos. of TYT Radio set along with Antenna, (17) 3(three) nos. of charger and (18) 1(one) no. of Adaptor from the spot i.e. foothill of Ushoipokpi at 5:45 a.m. and seized at 06:00 a.m. The massive searched operation was conducted from 05:00 am to 07:00 a.m. on the same day. Hence the case.


