Today i.e. 30/01/2025 at 05.50 pm received a reliable information that on the same day at around 05.45 pm, one Honda Activa, black in colour bearing registration number MN06SH 4461 playing from Wangjing side toward Khongjom Bazar side ridden by an unknown rider, collided with another Hyundai i10 Car, red in colour, without registration number, plying from opposite direction i.e. from Khongjom Bazar side towards Wangjing side driven by an unknown driver, near Dhaka Oil Pump, along NH No. 102, due to rash or negligent driving on the part of the unknown driver of Hyundai i10 Car, red in colour, without registration number. As a result of which the unknown rider and 02 (two) pillion ridders of Honda Activa, sustained serious injuries on their persons and evacuated to Hospital for medical treatment. And both the vehicles were also badly damaged.


