Today i.e. 05/02/2025 at 07.00 pm received a reliable information that on the same day at around 06.50 pm, one Honda Activa, grey in colour bearing registration number **MN07A-1301** playing from Khongjom Bazar side toward IVR Langathel side ridden by an unknown rider, dashed on the right side of one Honda Dio white in colour bearing registration No. **MN01C-5411**, while the vehicle Honda Dio was parked near Langathel Laikom Bazar, due to rash or negligent driving on the part of the unknown rider of Honda Activa. As a result of which the unknown rider of Honda Dio sustained serious injuries on her person and evacuated to Hospital for medical treatment. And both the vehicles were also badly damaged.

Hence a regular suo-motu case under **FIR No. 07(02)2025 KJM PS U/S 281/125(b) /324(4) BNS 2023** has been registered for investigation.


