With due respect, I am to report that on 21/01/2025 at around 8.15 pm, my Honda Activa 6G DLX (Decent blue metallic in colour) bearing regn. No. MN01AN-0806, Chassis No. ME4JF91AHNG372620 & Engine No. JF91EG7372930 and Model- 2022, which was registered in my mother's name i.e. Khundrakpam Prema Devi w/o Kh. Somen Singh of Thoubal Wangmataba Mathak Leikai, Thoubal was found stolen away by unknown person while parked at the front of the Shopping Complex of Thoubal Municipal Council, Thoubal along NH-102 under proper locked and was unable to locate after all the efforts put to locate the same till date.
