Today i.e. 29/01/2025 at 9:40 pm received information that on the same day at around 9:30 pm one Alto 800 car B/Regn. No. AS12P-2603 driven by an unknown driver coming from Yairipok side towards Thoubal side met an self-accident by dashing on the two numbers of electric poles which were erected along the road side of Kashom Khullen road near NRL Oil Pump at Thoubal Kshetrileikai due to rash or negligent driving on the part of the unknown driver of Alto 800 car. As a result of it, the unknown driver of Alto 800 car sustained injury on his person and evacuated to Hospital for medical treatment. The said Alto 800 car and two numbers of electric poles were badly damaged.
