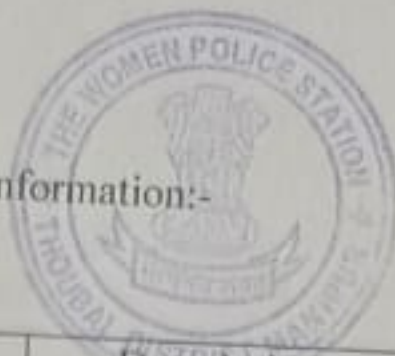

First Information contents:- On 24/1/025 at 13:00 hrs, one complainant namely Maibam Maipakpi Devi (45)yrs, W/o Sagolsem Eliteben @ Indramani Mangang, now residing at Salungpham Kangthokchao (Mayai Leikai), P.O Wangjing P.S:- Heirok, Thoubal District Manipur filed a written application in the court of Chief Judicial Magistrate Thoubal forwarded the same to OC, WPS-TBL on 27/12/2024, with direction to investigation the matter a report be submitted., 1. That the complainant got married to husband (Sagolsem Eliteben @ Indramani Mangang S/o Sagolsem Ibochouba Singh, Langathel Mayai Leikai, PS-Khongjom, District Thoubal, Manipur in the month of June, 2019. After marriage, the undersigned along with husband and other family members of the matrimonial home lived happily for the last about 3(three) years. Thereafter, throughout my stay in the marital home, my mother-in-law (Sagolsem Laibi Devi) and one of the sister-in-law (Sagolsem Kajal Devi) without any respect started to abuse me by using odd and slang languages on the issue having no child from the wedlock. However, the undersigned had tolerated the said acts of the mother-in-law and sister-in-law. It is also humbly submitted that the parental home of the undersigned is a poor family and living on daily waged basis. There is no proper source of income for the livelihood of the parental home.

2. That It is also beg to state herein that while the undersigned was in the marital home, she along with husband consulted many Doctors regarding the problem of having no child issue. For such doctor consultations and treatments, the undersigned had expenses huge amount of money with the hope of getting a child from their wedlock. Even the undersigned had also borrowed money from her near and dear ones with the consent of the husband. However, all efforts turned in a vain. During this treatment period also the husband sometimes said that he will marry another woman if there is no child from the wedlock. Not only the husband, even the mother-in-law had also said for remarriage of her son Sagolsem Eliteben@ Indramani Mangang with an another woman if no child issue from the wedlock.

3. It was also the situation that one Ms. Anju Devi (one of the daughter-in-law of the husband's near relative) had also used to say to the undersigned that if there is no chances of having child from the wedlock then the only option is to remarriage of the undersigned's husband with another girl. The said Anju Devi had also given so many misinformations to the mother-in-law and above named sister-in-law. As a result of which, in most of the time said sister-in-law in collusive with the mother-in-law had also giving harassment by using odd languages to the undersigned. In spite of reporting such abuse nature of mother-in-law and sister-in-law to the husband, he kept silent without saying anything. Having no alternative, the undersigned remained helplessly and trying to tolerate all such abusive nature and harassment with the hope that one day they will surely feel love and affection to the undersigned. However, there was no change in the abusive and cruelty nature of mother-in-law and sister-in-law. On other hand, the husband lived as a mere spectator without intervening on such harassment and cruelty acts of his mother and younger sister. In such way, the undersigned lived in the marital home with mental agony and depression for the last about four and half years. During this period, some of the abusive words and cruelty nature of mother-in-law and sister-in-law as well as husband are as under:

By mother-in-law:- Nayum Chatkhro, Nachasu Yaode, Nupi ama thirge etc. (Go back to parental home, no child issue, Will marriage with another girl etc.)

By sister-in-law :- Nachasu yaodrabanina ebungsi nupi am thirage, Nang leibna Nupi ama thiba yadre, Nangna thongba chak channingdre, Kari ashada hinglino



*khangde etc. (Since no child issue another girl will be engaged, because of you another girl could not be marriage, don't want to eat the food cooked by you, on what hope you are living etc.)*

**By husband :-**

**Ei kari haigadabno khangdre, Nakhoi masel yana-yanaba leiminou, Leiminaba yaroidaba oirgana nayumda leiruragero etc.** *( I don't know what to say, adjust with them for living, if not able to adjust will you stay to your parental home, etc.)*

4. That suddenly and surprisingly, during the last 6/7 months, the mother-in-law and sister-in-law in collusive with the husband started giving mental harassment in most of the time by using many odd and slang languages, which were out of control to the mind and survival of the undersigned. On 26/09/2024 and 17/09/2024, the mother-in-law and sister-in-law forcefully be threatening said to the undersigned to go back to the parental home. The said harassment was informed to the husband. However, the husband did not pay attention in the matter, Having no alternative, on 28-09-2024 (afternoon), the undersigned came back to her parental home at Salungpham Kangthokchao (Mayai Leikai), Thoubal District, in order to save her life. Some of such mental harassment and cruelty given to the undersigned during the said 6/7 months are as under :-

**By mother-in-law :-**

**Nayum Chatkhro, Nacha yaodraba nangna kari tougige haibano, Nasaktu Yengningdre, Emou nupi ama thirage, Nangna asum Leibana emou atopa ama thiba yadre, Ekai khangdabi, Echa nupada amuk ayetpa piranu, Emouni haiduna miyam mangda puthokpa ekaiye, Nasaktu U-mangolgee masakni, Nangna maram oirga yumgi charol-surol muttore, Nangi chanaba cheng leite yumsida, Nang echanupi Luhongba yaoba yaroi, etc.** *( Go back to parental home, since you have no child issue what are you thinking about to do, don't want to see your face, want to engage another girl for daughter-in-law, because of you another daughter-in-law could not be engaged, having no sense of shameful, don't make disturbance to my son, I am shameful to show you as my daughter-in-law before the public, your face is like a bad luck, because of you the heredity of the family will be lost, there is no food for you in the house, you cannot take part in my daughter's marriage, etc.)*

**By sister-in-law :-**

**Nangna maram oiraga ebungse ware, Nupi ama thibasud yadre, Kari wakhanda kanagi ashada hingninglino, ekai khangdabi, Nangdi U-mangolgee masakni, Nangna thongba chak channingdre, Hanjin-hanjin hairasu ekaidene, Nang eigee luhongb yaoba yaroi, Nang yaordi eigiee luhongba mangol oigadou mande, etc.** *(Because of you my brother is worry, another girl could not be engaged, on what mind and on whose hope surviving, don't have shameful, you are like a bad luck, don't want to eat what you have cooked, inspite of repeated saying don't have shameful, you cannot take part in my marriage, if you have taken part in my marriage then it will have a bad luck, etc.)*

**By husband :-**

**Ei emana haibaduda athingba piba ngamde, Yana-Yanaba asum Leiminou, Angang yaodabsina maram oirga pumnamaksi thokline, Khanglaga asum leiyo etc.** *( I don't want to give obstruction to my mother's choice, live as usual by adjusting, only because of having no child all these problems were happened, live be tolerating all the situations, etc.)*

5. That while the undersigned was in the parental home at Salungpham for about 7/8 days w.e.f. 28/9/2024, either the husband or the family members of marital home did not ask anything about the condition of the undersigned complainant. On 06/10/2024, in the morning around 7 am the mother-in-law again made a phone call to the number of undersigned and the same was received by my natural mother wherein blamed the undersigned stating inter-alias "not to come in the marital home" and further in the said phone conversation, the mother-in-law boldly stated that "she will not take back the undersigned again in the marital home and not to make any phone call to her son (i.e. husband)". Thereafter, the mother-in-law cut of the phone without giving chance of talking properly.

6. That it was also the situation that on that day of 06/10/2024, in the afternoon, the husband came to the parental home of the undersigned as Salungpham for discussing regarding the matter of leaving the marital home by the undersigned. Thereafter, the husband and the undersigned again returned back to the marital home at Langathel. However, when they reached marital home, the mother-in-law and



sister-in-law started shouting and scolding to the undersigned by using so many odd languages which were earlier used as stated above. They further scolded and threatened to the undersigned that if the undersigned did not leave the marital home immediately then the undersigned will face dare consequences. After few minutes, the husband asked the undersigned to go back to the parental home at Salungpham. Accordingly, they came back to the parental home in the late evening i.e. around 6:00 pm of the same day (6/10/2024). Thereafter, the husband by leaving the undersigned to the parental home, had gone to his home at Langathel.

7. That it is beg to state herein that such act and nature of the mother-in-law and sister-in-law as well as husband are domestic cruelty to the undersigned with a common intention for not having a child from the wedlock. The undersigned without any fault, has been subjected to cruelty, harassment and torture by the mother-in-law and sister-in-law in collusive with the husband in order to separate the undersigned from her husband as well as for leaving away from the marital home so that their aim of marrying another woman for the husband (Sagolsem Eliteben@ Indramani Mangang) could be achieved.

8. That having no alternative, the undersigned reported all the above situations to the Women Police Station, Thoubal on 14/10/2024 for taking an appropriate action as per law stating inter-alia that if such criminal act and abusive nature of the mother-in-law and sister-in-law in collusive with the husband is not handled by the Law of the Country, then the fate of the women like the undersigned, would be danger in their livelihood in this modern society. However, neither an appropriate legal action nor register an FIR case against the culprits has been initiated.

9. In view of the facts and circumstances stated above, the undersigned humbly requested that an appropriate action as per relevant provisions of law may kindly be taken up against the above named three persons (namely 1. Sagolsem Laibi Devi, mother-in-law, 2. Sagolsem Kajal Devi, sister-in-law and 3. Sagolsem Eliteben @ Indramani Mangang, husband) all of them are living in the same house at Langathel Mayai Leikai, PO - Wangjing, PS - Khongjom, District Thoubal for their common intention of committing the cognizable offence of cruelty, harassment and torture to a married woman, in the interest of justice.
