It is to report that following the killing of two non-locals at Keirak by unknown armed miscreants, massive operations have been launched at various suspected locations in the District. Today i.e. 16/12/2024, based on a reliable input, at around 01500hrs a search operation was conducted at Kakching Ching Kakpham area. The area was cordoned off and search was conducted. During the search, two unknown suspected individuals were detained along with four wheeler vehicle silver in coloured Maruti Eon car bearing registration no. MN0X7826. The said individuals identified themselves as

(1) Lisham Premananda Meitei @ Poirei (45) S/o (L) L. Ibocha Meitei of Thoubal Kiyam Siphai, Thoubal District.

(2) James Ningthoujam (44) S/o N. Khomdon Singh of Phousupat Leikai, Kakching District.

The individuals along with the vehicle were detained and taken to the office of CDO-Kakching for further verification.

On questioning, the two individuals disclosed that they were members of the banned organization KCP (PWG) and were working under the command of the s/s Chairman Lamyamba Khuman. It was further disclosed that Lisham Premananda @ Poirei was the s/s commander of the Nongpok Ningthou Tengol KCP People's war Group organizing Camp located at Kakching Mamang Ching Laifam Loknung. And he was tasked for carrying out extortion activities within Kakching, Thoubal and Imphal West District. James Ningthoujam disclosed that he was working under Poirei and was involved in serving extortion to various business establishments in Kakching District.

Following the Disclosures, the two individuals we arrested from the office of the CDO-Kakching one after another at around 1800 hrs. From their possession, the following items were recovered and the same were seized formally at around 1820 hrs.
