Today ie 18/12/2024, based on reliable input, a cordon search operation was conducted at Bijoypur Mamang Leikai and Makha Leikai. The search started from 0500 hrs. During the course of the operation, suspected individuals were detained and later taken to the office of CDO-Unit Kakching for further verification.

During questioning, the following 6(six) individuals disclosed themselves as cadres of the banned organization KCP(PWG).

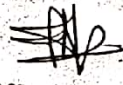

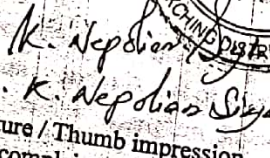
