I, Suresh Huidrom, resident of Khurai Salanthong Chaithabi Leirak, am writing to lodge a complaint regarding a disturbing incident that occurred at my residence on the night of August 20, 2024.

**Details of the Incident:**

**Date and Time:** August 20, 2024, approximately at 1:15 AM.

**Location:** Khurai Salanthong Chaithabi Leirak.

**Description:** At around 1:15 AM, a group of 5-6 miscreants, armed with sophisticated weapons, stormed the gate of our residence. They arrived in a white Hyundai Creta with a covered number plate. When my family members refused to open the gate, one of the miscreants threatened my sister, Sushila Huidrom, with a pistol at her. After a brief standoff, the miscreants left the site.

**Evidence:**

I have attached the CCTV footage capturing the incident for your perusal and further investigation.

**Witness:**

My sister, Sushila Huidrom, who was directly threatened during the incident.

**Action Requested:**

I humbly request you to identify and arrest the miscreants involved in this incident and to take appropriate legal action against them. This act has caused immense fear and distress to my family, and I believe prompt action will prevent any such future occurrences.






