I have the honour to state that on 28/05/2023 at about 02:30 am, my house located at Serou Makha Leikai was burnt down by large numbers of unknown miscreants suspected to be Kuki militants and their supporters. In that incident, I am currently hospitalized and staying at my daughter's home in New Checkon Nongpok Ingkhol due to health issues. Unfortunately, I'm unable to file an FIR for the fire incident at my house. I kindly request that a Zero FIR be filed on my behalf for this matter. In incident lots of my household properties were burnt into ashes. Particulars of the burnt items (1) UPS Inverter set with Solar Panel worth Rs. 87 thousand, (2) 1 No. of wooden Almirah worth Rs. 35 thousand, (3) 1 No. of Iron Godrej worth Rs.24 thousand, (4) 2 Nos. of wooden bed with accessory worth Rs.35 thousand, (5) 2 Nos. of Gas cylinder and Gas stove worth Rs.15 thousand, (6) Utensil worth Rs.30 thousand, (7) Clothing worth Rs.35 thousand, (8) Ornament worth Rs. 1 lakh and 60 thousand, (9) 2 Nos. of Stand Fan worth Rs.7 thousand and 5 hundred, (10)1 No. of Refrigerator worth Rs.18 thousand, (11)1 No. of Gas Box worth Rs.12 thousand and 5 hundred, (12) 65 Nos. of Paddy (Phou) bags worth Rs.45 thousand and 5 hundred, (13) 1No. of Washing machine worth Rs.23500/-, (14) Katcha house having 5 rooms worth Rs.600000 (Six lac), (15) 3 Nos. of Dukan plot with Essential item worth Rs. 900000/-, (16) 1 No. TV (Samsung brand 56 inch) worth Rs.35000, (17) 1 No. of dressing Table worth Rs. 12000, (18) 1 no. of Honda Activa (Two wheller) worth Rs. 10,5000 /- (19) 1 No. of Phiyan worth Rs. 8500 and (20) 1 No. of VIP Sopha Set worth Rs. 35900/- Total value of all items is estimated to be Rs.2,224,400 (Twenty two Lakh twenty four thousand four hundred only) approximately.

In this regard, I request you to take up necessary legal action at the earliest.
