Sir,

I, the undersigned would like to lay down few requests for your kind consideration and necessary action;

That, I am currently serving as Branch Officer in the Office of Deputy Commissioner, Imphal East District.

That, today i.e. 08-10-2024, I came across with a fake certificate issued in the name of Bogimayum Sayes Khan, S/o Bm Jiaonddin of Yairipok Tuliha Mayai Leikai, and in the said certificate my signature was found to be forged by some unknown person.

That, the said certificate is for Economic Weaker Sections (EWS), but it is pertinent to mention herein that our State has no provision for issuing such kind of certificate as Meitei/Meitei Pangal are availing certificate for Other Backward Classes (OBC).

That, despite these fact, some unknown miscreant forged my signature and the above named individual used the said fake certificate in a Government job Recruitment. Further, it used a seal of Executive Magistrate, Tuliha, below my forged signature, which is completely illegal in the eye of law and liable to be booked.

In the light of the above mentioned facts and circumstances, it is therefore requested to kindly register an FIR and book the culprit and punish as per the law of the land.


