I have the honour to report that on the night of 24/10/2024 in between 1:30 am to 3:10 am an unknown masked person dressed in hoodie had broke inside my house from the 1st floor around 24th October 2024 as seen from the CCTV footage installed in the house. The unknown person had stolen the above mentioned gold ornament i.e. 520gms worth Rs 40,00,000/- (Rupees Forty lakhs only) that was kept in the Almirah under lock and key while all my family were asleep. He stole the ornament by finding out the key of the Almirah that had kept secretly in the room. The unknown masked person fled from the house at 3:10am of 24th October 2024 after the commission of the crime.

It is therefore requested to take appropriate legal action against the unknown Culprit person, who stole my lost gold.
