With reference to the Subject mention above, I would like to make this Report to you for your kind action Please.

I Messac Lalropui age 45 s/o Lalkhawmawi a permanent residence of House No. 177, 3rd street New Lambulane P.O, P.S. Porompat, Imphal East Manipur, belonging to the Hmar Tribe / Community, due to fear and intimidation by the Majority Meitei, Our family ran for our lives on the 5th of May 2023 and seek refuge at Pillingkata, Guwahati Assam - 781029. Leaving our Home/ House bearing Patta no. 26(A)/862 (new) Dag No.5465/5556, area .061 acre. Under the Imphal municipality at 3rd street New Lambulane when violence broke out between two communities i.e on the 3rd of may 2023.

Recently I came to know from reliable source that our House was looted/goods stolen on 17th of April, 2024 by unknown persons as we have left all our household goods and Valuable assets and Documents inside our Property / Compound.

Due to the ongoing ethnic cleansing by the majority meitei community in the valley I was not able to file a FIR / Complain where the incident has occurred . In the given circumstances I humbly request you to kindly register an FIR and investigate into the matter.

I would be very thankful if you could do the needful.
