Subject: Report/ Complaint on looting/ Vandalism of properties and illegal occupant of EAC Church building and Quarter that took place on 17/04/2024 at around at 1:00 PM at 1st Street, New Lambulane, P.O., P.S, Porompat, Imphal East District-795005,

Sir,

With reference to the above cited subject, I have the honour to make this report to you for your kind and favourable action please:

1. That, I, Shri Lalthanzam @ Lalthanzam Amo aged about 72 years S/o (L) D.R. Thuoma of 04, Nehru Marg, Lamka, P.O., P.S. & District Churachandpur, Manipur State and an Executive Chairman, Evangelical Assembly Church, (EAC).
2. That, due to Ethnic Violence which broke out in the state of Manipur on 3rd May 2023, the Pastor and his family who were in the EAC Church Quarter, due to fear and intimidation by majority Meitei, run for their life and stay at Mantripukhri Assam Rifles Camp.
3. That, our Church building attached with Pastor Quarter situated at 1st Street, New Lambulane, bearing New Patta no: 1294, Dag No: 5445 measuring an area of 0.061 acre of class Ingkhol, having village name 26(A) Nongpok, Ingkhol, Imphal Municipality was looted/Vandalized and illegally occupied by the majority community as all our valuable goods kept in the Church and house hold items from the Pastor Quarter were left when the ethnic violence broke out between two communities i, e. on 3rd May 2023.
4. That, recently I came to know from some reliable source that our Church Building and Pastor Quarter was looted/Vandalized and illegally occupied by some miscreants as we left behind all our valuable assets inside our property/ Church compound.

5. That, due to the ongoing ethnic cleansing spearhead by the majority community within the valley district, I had no option to make a report at a place where the incident occurred.

6. That, I am now making a report when we came to know about the incidents through whatsapp video recently and after confirming the said news to be true.

In the given circumstances, I humbly pray to kindly register an FIR, investigate into the matter and punish the perpetrator as per the prevailing provisions/law of the country, and for this act of kindness, I shall remain obliged and thankful.




