On 10/11/2024 at 10 AM received an information that one YouTube video was found casted on a channel called Naga People's Voice by Mr. Ph. Helang Singh a self-proclaimed activist from the Kuki community stating in an interview that they will not recognise the Agri-cooperative system in the state and achieve their goal for separate administration. He further stated that the administration should otherwise how will they achieve a separate administration which isn't even possible. He also said that "The Prime Minister said there is no autonomy in Manipur. How do we prove there's no autonomy? It's because of the stress and interlocking violence". Such act of making of such inflammatory statement on public platform creates enormous propensity to commit offences, inciting waging of war against the Government of India, promoting enmity between different groups or groups of communities by words either spoken, deliberate and malicious acts intended to outrage amongst the communities of the state by conducting public mischief with intent to promote enmity, hatred amongst the section of people.

Hence a suo moto case under C.R.N. No. 5734/2024 P.R.I.-PS u/s 147, 148(196)(a), 253(d(b), 353(2) BNS-2024 has been registered for investigation.
