On 12.07.2014 at 10:40 received an information that one YouTube video was found posted on a channel called Naga Community. Mr. P. Hengam Sharma a self-proclaimed activist from the Kuki community stated in an interview with the Commission that he found the Naga Community on the state and achieve their goal for separate administration. The Naga Community is a religious, caste, and tribal, otherwise, non-tribe, they achieve a separate administration, which is not even possible in India. He pronounced that "The Prime Minister said there is no unity in Manipur. How do we prove there is no unity in India? It is unity, diversity and harmony in violence." Such act of making of such inflammatory statement on public platform creates serious conspiracies to commit offences, abetting waging of war against the Government of India, promoting enmity between different groups on ground of communities by words either spoken, deliberate and malicious acts intended to outrage amongst the communities of the state by conducting public mischief with intent to promote enmity, hatred amongst the section of people
