Further he was taken to Govindajee Temple and detailed him inside his office. Later, they the place i.e. Govindajee Temple leaving himself at the temple.

On further course of enquiry, the video footages provided by the complainant, it was found that some unknown miscreants with sophisticated weapons were seen entering premises of complainant's residence as well as inside of campus of Govindajee Temple

The acts committed by the unknown miscreants against the complainant are a threat to life with criminal intimidation.

So, the enquiry report is submitted to you for initiating a regular case so as to cause arrest of the unknown miscreants and to carry out the smooth investigation into the matter.
